Re: Your letter October 12, 2006

We refer to the letter you send us dated 12 October by The PublicRoot consortium.

You asked us to respond if UnifiedRoot associates are adhering to the code of conduct as published on our websites.

The description of an associate of UnifiedRoot is someone who works for or has invested in UnifiedRoot.

UnifiedRoot has a code of conduct that stipulates that no associate shall procure directly or indirectly more than 15 TLDs.

UnifiedRoot has investigated whether an associate has more than 15 TLDs, and our findings are that this is not the case. UnifiedRoot can confirm that we are committed to and following our code of conducts.

Secondly you asked us to clarify your investigations in the WHOIS about Ms Elizabeth Pauchet.

UnifiedRoot asked the organization TMF to officially react in a letter on this specific item. We attached the letter from TMF in this letter to you.

The TLDs of Elizabeth Pauchet were never accepted, and with the migration to our new back office we could finally correct this situation together with other corrections. Those TLDs are available for registration.

We trust that this letter with the attached information will satisfy you concerning the issues you mentioned in your letter.

We refer to the letter you forwarded to us dated 12 October 2006 by the PublicRoot Consortium dated 12 October 2006 re violation of UnifiedRoot Code of Conduct (the "Letter"). You asked us to respond in respect of the remarks made in this letter about the alleged association between TMF and UnifiedRoot.

TMF Group Holding B.V. (TMF) and its group of companies (TMF Group) are not in anyway associated with UnifiedRoot.

With respect to the remark of Greenland Turtle Compagny Ltd being registered at the same address as TMF (B.V.I.) Limited that could be correct. Our domiciliary and management services include providing a registered address for clients at TMF's premises. As such, Greenland Turtle Company Limited indeed can have the same address as TMF (B.V.I.) Limited, the TMF group company in the British Virgin Islands. This does not mean that Greenland Turtle Company Limited is associated with TMF. It is indeed not.
